Abstract Submissions

Criteria Considered for Selection

- TransCelerate does not endorse or promote any vendor or product, including any vendors or products that may be featured
 at the DDF in Action Day and DDF Vendor Showcase events.
 - Any vendor or technology company that has developed a solution that uses the USDM, SDR, or SDR Reference Implementation, is welcome to submit an abstract.
 - Vendors may jointly submit an abstract that will showcase interconnectivity between their two solutions using USDM.
- Vendors should focus on how the USDM and DDF solutions, such as the SDR or SDR Reference Implementation, have been or can be applied in practice to achieve protocol digitalization.
- Vendor product/solution is related to protocol Digitalization which enable downstream efficiencies
 - Vendor product/solution is available in production environment (not in development/testing phase)
 - Vendor product/solution is posted on the <u>DDF Solution Directory</u> (clickable link)
- The DDF in Action Day 2024 as well as the DDF Vendor Showcase events are not marketing forums or sales shows. Content that is highly promotional in nature, especially relating to features or functionality with no application of USDM, are not appropriate for these events.
- Space may be limited. Preference will be given to vendors who have not presented (or solutions that have not been featured) previously at any DDF event or webinar.
- Diversity of use cases across all submissions will be a consideration for selection.
